New Schools Interested: Somerset City Arts

Game Rules/Procedures

Result: Yes, coaches need to have a roster for all games.

Carlos organizes elementary t-ball, cross country, basketball, and soccer. Anyone interested can contact Carlos and he will also share that information with us when the time gets closer.

Schedules: Do we want to schedule games in person or have Oscar continue to do the master schedule?

- Vote: For volleyball, we will attempt to have everyone complete a Google form to help organize all of the information for scheduling purposes. If it works, we will continue to use that format. If it does not, we will re-evaluate the scheduling process.

Result: We will use a Google form to help organize all of the information for scheduling purposes and Oscar will do the master schedule.

Proposal: Have Oscar add to the schedule how many games we should be playing and if we are playing both home and away against each team, or if we are playing north/south.

Proposal: If there is a need to reschedule a game, conference games **MUST** be a priority. Additionally, if two schools cannot reschedule a game amongst themselves, the school that initiated the cancellation or reschedule will take a forfeit that **WILL** count against their record.

Proposal: If possible, can there be two weeks in between seasons?
